## CHICAGOLAND CLUB 50 GUEST ACTIVITY RELEASE AND WAIVER OF LIABILITY

Based upon my own physical fitness, training, conditioning and experience(s), I have made the determination that I can participate in this Club activity. I also recognize that advice dispensed through the Club may or may not be appropriate for me and it is my responsibility to make this determination.

I acknowledge that some of the Club’s activities may be a test of a person’s physical and mental limits and carries with it, regardless of physical fitness or experience, the potential for serious injury, death and property loss. I assume the risk of those losses by participating in this or any Club activity I choose to participate. Based upon my own physical fitness, training, conditioning and experience(s), I have made the determination that I can participate in this Club activity. I have not been advised not to participate in those activities I choose by a health professional. I also recognize that advice dispensed through the Club may or may not be appropriate for me and it is my responsibility to make this determination.

I, for myself, my past and future agents, attorneys, representative(s), predecessors, successors, assigns, heirs and/or executor **do hereby waive, release and discharge the Club**, its past, present and future officers, directors, agents, volunteers, any club members, or participants (in conjunction with this or other Club events), **from**

**any and all manner of liability, claims for damages, causes of action, proceedings, compensation, attorneys' fees, costs and expenses of suits, claims and demands whatsoever, which may arise in the future from my participation in this or other Club event(s).** I assume all other risks associated with participating in this or other Club event(s) that I choose to participate.

**I agree not to sue any of the Club members, directors, officers or volunteers** for any all claims or liabilities made which may be assessed against them as may be discharged herein.

**I agree to Indemnify and Hold Harmless the Club, its past, present and future officers, directors, agents, volunteers, any club members, or participants from any and all claims assessed against them** as a result of (1) my actions, inaction, negligence or willful conduct (2) the actions, inactions, negligence of the Club, its past, present and future officers, directors, agents, volunteers, any club members, or participants (3) the conditions of the equipment, weather, or area where the Club event takes place (4) or any harm or damage caused by an occurrence during the Club event or involving the Club.
